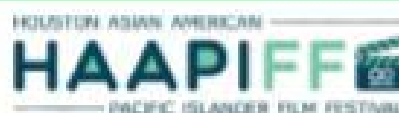

The RiceBowl Invitational

The Event: Rice University Mock Trial is proud to announce that it will be hosting the 2018 RiceBowl Mock Trial Invitational from October 12 - October 14. Competing teams will come from Rice and other schools in Texas including Baylor, UT Austin, and Texas A&M, along with teams that are coming from out of state institutions including Miami University, Oklahoma University, and Millsaps College.

What is Mock Trial?

Mock Trial is a competitive opportunity for undergrad students to get experience with legal reasoning and the nuances of the jury trial. Some students play witnesses, others attorneys, and over the course of 3 hours a compressed trial is held, including opening and closing arguments and 3 witnesses called by each the plaintiff and the defense. Each student is scored on his or her performance, and the team with the most total points is the winner.

Come Judge!

If you have a either a J.D. or College Mock Trial experience, you are qualified to judge and we would love to have you! No prior experience is required. Your position as a judge would carry the duties of scoring the competing teams according to a straightforward ballot system, which we will provide you information about. Additionally, you may be asked to act as presiding judge for the round you are scoring. If you are available to judge, please email jpp3@rice.edu.
